Technical Daily - November 1, 2021



S&P 500

U.S. Markets finished the week on a strong note with new all-time highs in both the S&P 500 (+0.19%) and NASDAQ Composite (+0.33%), and a new closing high on the Dow (+0.25%). This marked the 4th straight week of higher closes. Although all three major indices closed higher, sector participation was sparse. Only Health Care (+0.95%), Communication Services (+0.83%), and Tech (+0.43%) posted gains for the day. Real Estate declined the most at -1.19%, followed by Energy (-0.67%), and Utilities (-0.63%).

Breadth was negative on the S&P 500 at -74 net decliners and was also negative on the NYSE with decliners outpacing decliners 1.08x to 1 on 63% down volume. Advancers slightly outpaced decliners on the NASDAQ Composite at 1.03x to 1 on 54% advancing volume.

All Fed meetings carry a lot of notoriety, but this one will carry extra weight given the current environment of elevated inflation. This is a big week for macro including ISM today, the FOMC Decision on Wednesday, culminating with Non-Farm Payrolls on Friday.

Futures are higher this morning with the Dow leading the way (~0.40%). Continue to watch 4616 and 4672 for potential resistance on the S&P, which are Fibonacci projections. Watch the 50DMA for initial support (currently at 4464) followed by 4280.
